The Scholarship Committee consisting of Tracey Wheeler, Missy Malechek, Colleen Hicks and Cindy Harreld met on Wednesday, May 11, 2011 to determine scholarship recipients. Fourteen scholarship applications were submitted with seven of them being for TCCE Annual Conference and seven being for Institute. The committee made two decisions early in the process – 1) That we would not give scholarships to more than one person in a chamber and 2) That we would not give a scholarship to someone who received a scholarship last year. These exceptions ruled out three of the applicants for TCCE Conference and one for Institute.

The committee had \$6,500 to work with and determined that GCCE would give four scholarships in the amount of \$275 (TCCE registration) and four Institute scholarships in the amount of \$1295 each (full registration). The total is \$6,280.
